## SHELF LIFE

1 year from delivery. +15°C to +30°C, stable temperature in the original box protected by sunlight, in a clean and dry area. Due to the weight of the roll, store film inside its original packaging with roll caps, to avoid lines or defects from appearing. Store horizontally with cap-sheet and in original packaging, with a maximum stack of six boxes. Material without cap-sheet must be stock in vertical position.

*\* The shelf life is an estimate, subject to influence from external and uncontrol – lable factors, particularly if storage conditions are not adhered to.*

## CARE AND MAINTENANCE

- ☑ To prevent stains, remove insects, resin, tar, and debris from the PPF as soon as possible.
- ☑ Do not use solvent-based bug and tar removers.
- ☑ Wash and wax the vehicle as needed.
- ☑ Use only soft, non-abrasive gloves and drying materials.
- ☑ During washing, keep the high-pressure nozzle tip at a distance of 36 inches from the PPF.
- ☑ It is recommended to apply non-abrasive waxes or sealants once every 4 months.
- ☑ Do not use polishing compounds, clay bars, or waxes that contain dyes or abrasive agents.
